PROPOSALS FOR CHANGES TO THE IALE STATUTES HAVE PASSED

In conjunction with the election of vice-presidents for IALE, the members were asked to vote for or against a number of changes to the existing IALE Statutes. Out of the 1421 members, 166 (11,7%) members responded to the request. Among these 166 members, 144 members voted in favor of all the proposed changes, whereas 4 members voted against all of the proposed changes. Sixty-eight to seventy of the voters (41-42%) voted in the following ways regarding individual amendments. Based on these results, all the changes to the Statutes are accepted and are effective immediately.

GROWING PARTICIPATION BY THE IALE 2009 ELECTION

From 24th of February until 15 April 2009 411 members responded to the distributed material for the election of two Vice-Presidents for the IALE Executive Committee. The members were free to vote for up to two members among the five candidates. Threequarters of the ballots had 2 votes for two candidates and one-quarter for only one candidate. The votes for the different candidates were as follows:

The underscored members, Boije Fu and Sandra Luque were thus elected as vice-presidents for the IALE Executive Committee for the period 2009-2013. Compared to the elections to the Executive Committee in 2005 and 2007 there has been a considerable increase in the voting turn-out:

EALE – A NEW EUROPEAN CHAPTER OF IALE

On the 13th of July, 2009, during the European Congress on Landscape Ecology in Salzburg, a foundation of a European Association for Landscape Ecology (EALE), as a chapter of IALE, will take place.

The foundation meeting running from 17:30-20.30 will consist of three parts:

- 1) A General Assembly
- 2) A roundtable discussion on the perspectives of EALE
- 3) An open reception: Terroirs of European Landscapes

The European Association for Landscape Ecology (EALE) has been under construction for many years. It originated in an internal need to coordinate EALE meetings at a European level, especially the superregional meetings between the IALE Congresses, but the perspectives in organising landscape ecologists at a European level proved to show a variety of possibilities that has been investigated during the last five years.

The structure and related statutes as well as external relations have been discussed intensively. They should ensure representativeness in the IALE Council, facilitate the cooperation between European landscape ecologists and act as a platform at the science-policy interface to assist policy making at the European level.

The importance of landscapes are growing in Europe.

With the passage of the European Landscape Convention in 2004 the European Council has undertaken legal responsability concerning landscapes in Europe. Also the European Commission and related organisations have substantial influence on and growing interest in the development of European landscapes. Contacts to the European Council as well as to the European Commission and related organisations (e.g. the European Environmental Agency (EEA)) have been established to facilitate the involvement of our membership expertise in the implementation of the European Landscape Convention and in the planning and management of the European landscapes

Plans for the development of landscape ecological education at a European level are under development, especially at the PhD-level to ensure new generations of European landscape ecologists.

A strengthening of the interests of educated professional landscape ecologists within landscape planning and management has been initiated with the goal to establish a specific organisational frame within EALE for these members.

Statutes ensuring a flexible combination of individual and national chapter based membership, and promoting election of the EALE executive committee through the formation of voting-list with different programs for the development of EALE are established.
