

Dear IALE Members,

As the end of the year approaches, it is a good time to reflect back on the year, both the successes and challenges, and to contemplate what the year ahead will hold. It goes without saying that 2020 has been a year of incredible challenges. The IALE executive committee has worked incredibly hard to move our society forward even while constantly shifting our focus as events require.

In conclusion, although our world has seemed torn asunder at times, IALE has become a stronger community, digitally connected. This new strength will serve us well in the months and years ahead. Although we might assume that 2021 can only be better, there will likely be new and unforeseen challenges. The discipline of landscape ecology has a huge role to play in helping people and landscapes meet and survive these challenges. Our pledge to you is that IALE will continue to adapt in order to serve our members and to shift our world towards a more sustainable future, regardless of the difficulties ahead. In 2021, we look forward to electing new IALE executive committee members, major updates to our website, and more opportunities for members to visit the world - virtually, of course.

Like many of you, I will be staying at home with my immediate family (husband and two dogs) and will not be able to visit



family during the 2020 holiday season. I suspect many of us will be more isolated and disconnected. Nonetheless, I hope the holidays are an occasion to reflect on your own resilience, to be thankful, and to recharge your batteries for whatever 2021 throws at us. IALE's new membership management system

At the beginning of 2021 IALE–World will implement a new, state-of-the-art membership management system (MMS). This will support communications for our international scientific community by bundling a number of our communication channels and creating new ones. After a selection process, the Executive Committee agreed this year on a system from the Canadian provider Wild Apricot and began preparations for the launch of the membership management system.

Website, newsletter, membership database

The MMS will combine the most important elements of IALE's communication: a

privacy compliant membership database, the automated dispatch of our newsletter and bulletin, and a new website. The free access for IALE members to the online edition of our flagship journal Landscape Ecology will also be regulated by the new MMS.

National chapters will have the possibility to manage their membership (registration, maintenance of personal data) completely via the new MMS. For smaller chapters this could be an attractive solution also to manage the payment of the membership fees - if you are interested please contact the Executive Committee directly.

Where a national chapter is not present, interested scientists will be able to join

IALE-World and pay their membership fee directly through the IALE-World website.

The roll-out of the MMS, including the new website, is expected to take place in mid-January. All IALE members will receive a corresponding e-mail at that time including new login credentials to get access to special services, such as the free access to Landscape Ecology. During the year, each new member will receive the login credentials valid for 2021.



1st International IALE-Russia conference

The 1st International IALE-Russia conference «Landscape Science and Landscape Ecology: Considering Responses to Global Challenges» which had been planned to be held in Moscow by Lomonosov Moscow State University at 14-18 of September 2020, took place on the same dates in the online format, becoming our first considered response to the global pandemic.

The conference program covered five main topics:


- Landscape spatial structure and dynamics symposium consisted of five sessions which addressed mainly theoretical questions of modelling landscape structure and processes in different scales;
- 2. Natural hazards symposium discussed problems of land degradation, wild fires, transformation of Arctic, landscape epidemiology and attracted the attention of many specialists from sister disciplines geomorphology, cryolithology, medical geography;
- Historical landscape ecology, a traditional topic on the IALE agenda, touched the questions of land cover change and transformation of energy balances;
- Landscape assessment and planning symposium focused on ecosystem services assessment, nature based solutions and social-ecological systems;
- 5. Land use and land management symposium examined land adaptation to different types of use recreational, agricultural, urban, etc.

The conference online platform gave the participants an opportunity to manage personal pages of their presentations, to upload pdf files with presentations for off-conference viewing and to discuss their research in a chat linked to the page. On these very pages we placed the video recordings of the presentations and everyone is welcome to watch them at the conference website iale.conflab.ru via Guest login. To find a topic of interest, browse through the program, either by day or by session.

The number of participants changed with the time, by the beginning of the conference we received 237 theses, but 39 authors didn't show up for their talk. Nevertheless, their absence was compensated by 45 newly registered attendees. Since this was the first IALE-Russia conference, all members of the Russian chapter presented their work and dominated among the speakers. The geography of the rest of the speakers was predominantly European, however, there were participants from Japan, Kazakhstan, India and the USA.

disco party that lasted over 3 hours during which people were chatting, making friends, drinking and even sporadically dancing. The second event, unfortunately, was designed for the Russian audience only since it was a poetic evening named "The Poetry of the Place" when our colleague Iya Mironenko read her landscape lyrics that was amazing.

Geograpy of the conference speakers



The video conference was held in four parallel virtual rooms integrated into the online platform. The attendance of the sessions was approximately 20 to 40 people, the plenaries gathered up to 80-90 people. As we see, the fickle audience will be typical for all online events since the participants stay on with their regular local activities and generally find the time for their talk and session only. But on the other hand, the online format gives a chance to a wide range of scientists to promptly join the conference talks of their interest.

Informal part of the conference consisted of two social events. The first was an online

Conference Report Socio-Ecological Practice Research for Sustainable Landscape Governance, 6-7 September 2020.

The international conference was jointly organized by the European Land-Use Institute (ELI), Research Institute of the University of Bucharest ICUB, the international journal Socio-Ecological Practice Research (SEPR) and IALE Romania.

The *Opening session* was addressed by Ileana Stupariu, professor of Landscape Ecology at University of Bucharest and president of IALE Romania, followed by Christine Fürst, president of ELI, past president of IALE-World, who declared the Conference officially open at the end of their statement.

The *Welcome speeches* were delivered by Carmen Chifiriuc, Vice-rector and head ICUB, Laura Comănescu, Vice-rector of University of Bucharest, and Alexandru Nedelea, Dean of the Faculty of Geography.

The *Plenary sessions* were held by Jianguo Wu, Professor of Sustainability Science at Arizona State University, Editor in Chief of the Landscape Ecology journal, Christine Fürst, Professor of Sustainable Landscape Development at Marthin Luther University Halle Wittenberg, Jiquan Chen, Professor

of Geography at Michigan State University, and Robert Scheller, Professor at North Carolina State University and President of IALE International.

The Conference spread over two days and covered six topics divided in sessions, as follows.


- European Landscape Convention 20 years. Best practice examples: from scientists to practitioners
- Novel technologies, instruments, modelling and knowledge implementation in Geo and Life
- Global pressures / land-use change, landscape resilience
- Landscape governance as a socioecological practice: historicistic and international perspectives
- Ecological wisdom for sustainable landscape governance: exemplary cases from around the world
- Ecopracticology: a new name for some old ways of thinking.

A total of 155 people participated in the Conference, including 49 Romanians and 106 participants from Italy, Chile, Spain,

Argentina, Russia, Germany, Finland, United States, Mexico, Croatia, Estonia, Slovakia, Nigeria, Poland, Georgia, Austria, Brazil, Algeria, Vietnam, Tanzania, United Kingdom. The conference was moderated by moderators from Romania and abroad.

Some Working Groups, however, seem to have paused their activities or at least they do not report on them. In September 2020, a short survey was sent out to all Working Group lead teams, collecting information on i) changes in WG organisation, lead team, objectives etc.; ii) progress in WG works, organised events, etc.; iii) related publications or other outreach; and iv) other relevant information. We received detailed replies from altogether six WGs and unfortunately no response from the remaining WGs.

We would like to encourage all IALE Working Groups to report their activities to the IALE EC and to provide respective texts to be published in the IALE Bulletin, Newsletter and on our Website. This provides you a great chance to promote your activities and to share it with the large global IALE community.







We would like to thank all our supporters in 2020 - without whom our achievements would not have been possible:

2020 has been a challenging year for all of us and a busy year for Landscape Online going along with a number of substantial changes and developments. We have handled about 36 manuscripts in this year and published 9 articles so far - further manuscripts are in a much progressed stage, expected to be published within the next few months. This would not have been possible without the support of many. First, we would like to thank all reviewers (see list in the right column, in alphabetic order) for dedicating us their valuable time and expertise during the review process. Furthermore, we would like to thank all IALE chapters that decided to become journal partners to support our work, namely the regional chapter IALE-Europe and IALE-North America and the national chapters IALE-Chile, IALE-Denmark and ialeUK. Since the German IALE chapter has launched this journal in 2007, Landscape Online took major steps towards internationalization. We also thank IALE for the financial support that enabled us to offer all IALE members the publication in our journal with a feewaiver. Furthermore, we are grateful for the support of our 18 editorial board members: Leila Mahmoudi Farahani (Australia), Veerle Van Eetvelde (Belgium), Jochen A. G. Jaeger (Canada), Cristian Echeverria (Chile), Dolors Armenteras (Colombia), Andreas Aagaard Christensen (Denmark), Hannes Palang (Estonia), Christoph Merz, Claus Dalchow, Dagmar Haase, Olaf Schroth, Stefan Heiland (Germany), Emilio Padoa-Schioppa and Irene Petrosillo (Italy), Janez Pirnat (Slovenia), Simona R. Grădinaru (Romania), Audrey L. Mayer, and Jessica Price (USA). As we are continuously looking forward to complement and enhance our editorial board with further competences, please get in touch with us in case you are interested to become involved.

Changes in the Editorial:

One big change of this year effects the journal's editorial as Peter Weißhuhn will leave the editorial management by the end of this year. He has been incredibly supportive during the past two years, while restructuring our journal and establishing

our new web-based journal management platform. Due to new obligations for the World Wildlife Fund (WWF), he will not be able to keep up support in this intensity. However, we are glad that he keeps affiliated as editorial board member and thank him very much for all the support he committed so far.

Therefore, we are glad to win Uta Schirpke as a new Co-Editor-in-Chief and thank her for the willingness to take this responsibility. Uta is senior researcher at the research group Ecosystem and Landscape Ecology at the University of Innsbruck (Austria) and the Institute for Alpine Environment at the Eurac Research in Bozen (Italy). She has already been very supportive in previous years as member of the editorial board. As associate and guest editor for other international journals such as Ecosystem Services, she will bring valuable experience and we are really looking forward to this new collaboration.

Additional journal quality criteria:

Besides all these events and changes, we kept being busy, working to increase transparency and visibility of our journal quality criteria. Since this summer, our publishing policies are acknowledged by SHERPA/RoMEO and registered in its database that aggregates publisher information worldwide to provide summaries of copyright and open access archiving policies. With this, Landscape Online successfully accomplished a goal as SHERPA/RoMEO is an important reference for open access standards. Furthermore, we make the first steps towards Plan-Scompliance. Plan-S comprise principles and criteria for open access journals and platforms supported by national research agencies and funders of twelve European Countries (cOAlition-S) to promote open access science publishing by state-funded research organisations and institutions. Landscape Online is positively evaluated by the beta version of the Journal Checker Tool (JCT) that just launched in November. We are glad to have successfully passed this step as the JCT provides a tool for researchers to find journals that comply with Plan-S aligned Open Access policies. In 2021, our next milestone is the application for the DOAJ Seal - which is awarded by the Directory of Open Access Journals (DOAJ) to journals that demonstrate best practice in open access publishing.

Thus, we believe Landscape Online can usefully supplement the variety of scientific journals in the field of Landscape Ecology offering an opportunity to publish Open Access with highest quality standards. Accordingly, we are looking forward to the submission of further new and interesting manuscripts waiting to be published open access at www.landscape-online.org. We wish you all a powerful and good start into the new year 2020! We are also looking forward to the upcoming IALE European Landscape Ecology Congress, taking place in Poland, in July 2021, and hope to meet you all there in physical reality.

Special Issue in Landscape Ecology: Toward a Science of Scaling in Landscape Ecology

Landscape ecologists have long known that spatial scale can impact analyses, and scale has been a key topic in the discipline for more than 30 years. To scale something means to change the size while maintaining the same proportions, and a bevy of research in our field has investigated the impacts of changing spatial, temporal, and level of organization scales on research outcomes. Scaling, on the other hand, is a way of measuring the unmeasurable (Torgerson 1958) by translating information from one scale to another in space and/or time. Established scaling relationships built from measured values can provide the opportunity to predict values at unmeasured scales. Indeed in the seminal paper "Key issues and research priorities in landscape ecology: An idiosyncratic synthesis", Wu and Hobbs (2002) identify scaling as a key priority, not scale, noting that "general 'rules of thumb' and specific techniques for scaling...need to be developed and tested more widely and rigorously." Yet, nearly 20 years later, we still lack a 'science of scale' in our field.

At the same time, ecological and socioecological data are nearly always structured by different forms of clustering that are reflective of scale. Hierarchically, local environments are nested within larger regional environments, daily behavioral patterns are nested within seasonal variations, and species are nested within genus. When more than one level of clustering exists, cross structures can also exist such as when a migrating species travels between locations in different branches of an environmental hierarchy. Ongoing innovations such as those in multilevel modelling create opportunities to partially pool information across scales, stabilize parameter estimation, and improve our inferences about ecological and socio-ecological processes. These methods have the potential to create insights that can form the foundation of a richer theoretical understanding of scale, and lead to innovations in our ability to conduct scaling.

We invite papers that address this key need to develop general 'rules of thumb' and specific techniques for scaling information across scales in space and time, translating knowledge across organizational levels, and extrapolating experimental results to real-world systems. We encourage submissions that develop new techniques for prediction and extend theories that have been established in other fields such as physics and biology. We also encourage review and perspective papers. We will put less weight on submissions that simply examine the impact of different spatial scales on patterns or processes.




ESP Conferences: Special Update
